SECTION 1: UM COMMUNITY ENGAGEMENT GRANT SCHEME

1.1 Preamble

Universiti Malaya Community Engagement Grant Scheme aims to benefit community with output from UM research by offering community engagement grants and matching fund. This grant scheme is managed by UM Community Engagement Centre (UMCares) that connects UM researchers with the community as beneficiaries. Involvement of the community enables co-creation of knowledge which is led by UM researchers, and this is expected to produce positive impact and sustainable social change.

We welcome proposals that are supporting the UMCares project cluster which are sport and recreation, social welfare, entrepreneurship, environmental development, ICT and technology, rural development, education, health, national and cultural heritage conservation. We also focusing on research projects that aimed on the Shared Prosperity Vision 2030 (SPV 2030) enablers and benefiting community listed in the SPV 2030 polarity management which are B40 group, poor and economically vulnerable, community in economic transition, indigenous community, person with disabilities (PWD), youth, women, children, and senior citizen. Research projects that align with themes and policy enablers of the Twelfth Malaysia Plan, Framework of the 10-10 MySTIE, Malaysia Education Blueprint 2015 – 2025 (Higher Education), and United Nation's Sustainable Development Goals (SDGs) are also welcome.

Apart from the grants, we are offering Partnership Matching Fund (PMF) where our role is to incentivize and sustain the keen interest and aim of our collaborators, construct their capacity to lead, strategize with UM researchers, and give unrestricted opportunity to policy making. Not only for our collaborators, empowering the targeted community's capacity to manage solutions by solving issues relevant to the community needs is also the key objective of this fund.

Two specific programs are also being offered under this scheme, which are Nadi Lembah Pantai (NLP) and Kelab Sahabat (KS). NLP is a program to communicate directly with the Lembah Pantai community representative to identify issues and collaborate with stakeholders. KS is a program which supports the Ministry of Education's school community in Petaling Utama and Bangsar / Pudu districts via a knowledge transfer program. These programs have a unique application process and criteria but focusing on the same grant areas as listed for UM Community Engagement Grant.

SECTION 2: UM COMMUNITY ENGAGEMENT GRANT

2.1 UM Community Engagement Grant

2.1.1 Introduction

UM Community Engagement Grant funds action research that is conceptually applying multi / inter / trans-disciplinary research. This grant can be offered to any existing research projects that are aimed to test application of their research's output to the community. The applicant who has active collaboration with organisation, industry, NGO as project stakeholder will be prioritised to be awarded. The project stakeholder is encouraged to be an entity that supports a social cause and a registered company or association that possess a revenue source that is able to maintain their social mission. Applicants are not allowed to be project leader for another UM Community Engagement Grant at the same time. Projects that targeted the B40 group, poor and economically vulnerable, community in economic transition, indigenous community, person with disabilities (PWD), youth, women, children, and senior citizens will be prioritised to be awarded.

2.1.2 Grant Objectives

Objectives of the UM Community Engagement Grant:

- To solve community issues in Klang Valley.
- To implement research output to the community through action research.
- To empower the community's capacity to manage and sustain solutions.

2.1.5 Grant Eligibility Criteria

- 1. Open to all Universiti Malaya academic staff (Associate Professor, Senior Lecturer, and Lecturer) as project leader permanent or contract.
- Academic staff as project leader with contract status, a minimum appointment of twelve (12) months is required (contract is active within the project implementation period) and members of the project must involve at least one (1) permanent academic staff.
- Proposed project is encouraged to be interdisciplinary and benefiting at least two (2) communities. The Kelab Sahabat program is encouraged to involve at least five (5) Ministry of Education's schools in Petaling Utama and Bangsar / Pudu districts.
- 4. Project applications that have active engagement with collaborators / stakeholders (organisation) will be prioritised to be awarded.
- 5. For a proposed project that has collaborators, proof of university-organisation collaboration and proof of monetary and non-monetary contribution, e.g., letter of intent need to be provided as attachment to the application.
- 6. Projects that have existing research output (module, prototype, etc.) and to be applied for benefiting targeted communities will be prioritised to be awarded.
- Proposed project must be able to show the capability and readiness to change community knowledge, behaviour, skills, and aspiration. This is parallel to three (3) stars rating for Section G6: Networking & Linkages, Malaysia Research Assessment (MyRA).
- 8. Proposed projects must be able to demonstrate short and middle-term impact in their progress and final reporting (the targeted impact to be achieved must be able to be reported for a minimum six (6) months and maximum 12 months of the project implementation period).
- 9. Proposed project must be able to deliver a sustained output (a continuing practice of the module or prototype introduced by researchers) to the community for solving issues and improving their livelihood in the long-term.

2.1.6 Grant Non-eligibility Criteria

- 1. Project proposals that are supporting political agenda as part of initiatives to benefit targeted communities will not be considered for proposal evaluation.
- 2. Profit-making, charitable purposes and faith-based project proposals are not eligible for this grant application.
- 3. Project proposal that is focusing on funding physical amenities, equipment, refurbishment of the working area as an initiative to solve community issues will not be considered for proposal evaluation.
- 4. Project activities bearing cost for bank charges, guarantee costs, debt services charges, provision for future liabilities, cost for fine, penalties, and litigation expenses are not allowed.

• Maximum RM 20,000.00 per project.



SECTION 3: UM PARTNERSHIP MATCHING FUND

3.1 Partnership Matching Fund

3.1.1 Introduction

Partnership Matching Fund (PMF) is a matching fund provided by UMCares to researchers who already received funds from local agencies / industries and therefore named as an organisation, to carry out community projects that will benefit the targeted community.

Project leaders who received funding from local organisations and interested in applying to PMF must send applications to UMCares. Application can only be processed after the UM researcher through Universiti Malaya had successfully received funding from the funder. Approvals are subjected to the panel's decision and upon successful PMF application, the matched fund must be administered by Universiti Malaya via UMCares.

3.1.2 Fund Objectives

To encourage UM researchers to source out local organisation funding for community projects or programs and to strengthen the university collaboration with external organisations as collaborators.

3.1.3 Fund Eligibility Criteria

- 1. This fund is open to all UM researchers who are successful securing funds from local organisations (government / agency / industry).
- 2. Applicant and project criteria as listed in point 2.1.5 Grant Eligibility Criteria and 2.1.6 Grant Non-eligibility Criteria.
- 3. Project leader and members should be competent in skills for knowledge transfer and able to deliver expected output and outcome.
- 4. Project leader who already received funding from UMCares as an active project is not entitled to apply.

3.1.4 Quantum of Funding

Quantum of funding is applied in a ratio of 3 : 1 (organisation fund : PMF fund). A funding from an organisation with a maximum of RM20,000 and not less than RM10,000 per project. The amount to be matched by PMF is subject to fund availability.

3.1.5 Scope of Funding

The funding can be utilised for these votes:

Vote 11000 - Salary and wages	 Temporary and Contract Personnel who are directly involved in the project.
Vote 21000 - <i>Travelling and</i> <i>Transportation</i>	 A maximum of one overseas visit* or conference per year is allowed during the duration of the project. Only the project leader or a senior applicant member (not student or research assistant) is allowed for overseas trip. Travel is limited to economy class and using the shortest direct routes. No virement of funds are allowed from other categories. *Not more than 25% of total grant (including all local. fieldtrips).
Vote 24000 - Rental	 Rental expenses for space, equipment, transportation, and other items directly related to the project. *Rental for transportation must be managed by licensed transport company.
Vote 27000 - Project Materials and Supplies	 Only expenses for materials and supplies directly related to the project can be included.
Vote 28000 - Maintenance and Minor Repair Services	 Only expenses for minor modifications and repairs of the equipment or any other item directly related to the project. (No renovation of laboratory or office spaces allowed).
Vote 29000 - Professional Services	 Includes expenses for special services directly related to the project (such as payment for enumerators, usage of computer facilities, chemical analysis, and data processing). Any expenses for the international collaborators will not be borne under this PMF.

Vote 35000 - Accessories and Equipment	•	Only purchase of special equipment and accessories (including accessories to upgrade the capability of existing equipment) directly related to the project can be included.
		*Less than RM 10,000 per equipment and not more than 30% of grant.

3.1.6 Funding Period

- Funding period is following the contract between UM and the collaborator.
- Request for project extension must be made to the Director of UMCares.

SECTION 4: UM COMMUNITY ENGAGEMENT PROGRAM

4.1 UM Nadi Lembah Pantai

4.1.1 Introduction

UM Nadi Lembah Pantai program is an initiative by UM through UMCares to approach the community particularly those residing near UM. The program is a platform to communicate directly with the community representative to identify issues and stakeholders, e.g., school, industry, etc. to develop research mapping. On the development of this Lembah Pantai community ecosystem, replication will be applied to other community ecosystems near UM, i.e., Kampung Tunku, Petaling Jaya and Damansara. UM Nadi Lembah Pantai is a holistic program involving all UM community (academic staff, non-academic and student) from various responsible centres in UM. This program is focusing on three focus area:

- Health and Well-Being
- Education
- Environment

Other than these areas are also covered, subject to the community issues and suggestions by UM researchers. Target communities for this program are children, youth, adults, and senior citizens. This program also aims to close the gap among the B40 and T20.

4.1.2 Program Objectives

To provide a platform for the UM community to collaborate with Lembah Pantai community, local industry, government agency, and non-governmental organisation.

4.2. Kelab Sahabat

4.2.1 Introduction

This program opens to all UM academic staff to conduct action research with schools in Petaling Utama and Bangsar / Pudu districts. The school program is one of UMCares networking programs named as Kelab Sahabat. This program has started since 2016 engaged by a memorandum of understanding between UM and Pejabat Pendidikan Daerah (PPD) Petaling Utama. This program is focusing on areas addressed by the school community and UM researchers.

4.2.2 Program Objectives

To support the school community in Klang Valley through the national school curriculum and co-curriculum via knowledge transfer program.

- Following general criteria provided in Section 2 and Section 3: UM Community Engagement Grant and Partnership Matching Fund (PMF) respectively.
- Minimum 5 schools under Kelab Sahabat participate in a program.
